

ILO Diagnostic and exposure criteria for occupational diseases: the Final Meeting of the Working Group and the Public Conference Held at the University of Milan (Italy) on June 2017

The first ILO list of occupational diseases was established in 1925, and the disease mentioned above, together with lead and mercury poisoning, were the first occupational diseases put on

this list, and in 1934 the revised list of occupational diseases contained ten items. The 1964 International Labor Conference introduced a separate Schedule (List of Occupational Diseases), appended to the Convention, and which allowed for amending the schedule without having to adopt a new Convention. The ILO Employment Injury Benefits Convention recommends each Member State to adopt a list of occupational diseases that at least includes the diseases listed in Schedule I to the Convention, which needs to be periodically updated. The last update of the ILO list was approved in March 2010, following a preparatory technical meeting held in Geneva in December 2009.

Together with the approval of the list, an International working group, made of experts from all corners of the world accepted the task from ILO of preparing criteria to incorporate a specific disease in the list. The working group was appointed in 2011, and its starting task was to prepare for each of the entities in the ILO list, and for the several “open items,” one mini-monograph regarding the diagnostic and exposure criteria, totaling 112 documents. Each of the 112 monographs is divided into six sections, and the contents are articulated as follows:

- (i) General characteristics of the causal agent/disease;
- (ii) Occupational exposures;
- (iii) Short profile of the toxic agent/disease;
- (iv) Name(s) of the disease(s) and the related ICD-10 codes
 1. Acute, chronic and long-term effects.
 2. Criteria for diagnosis,
 3. Minimum levels of exposure,
 4. Latency and induction period
- (v) Key elements for prevention
- (vi) Further reading

The importance of the new ILO diagnostic criteria was highlighted during a public event held on the 27th June 2017 in the historical building of the University of Milan, which was at the time of its construction in the XV century one of the most rational hospitals in Western Europe. More than 70 participants from at least 20 different countries gathered to participate in the Event, to share their experience and opinions on occupational medicine in their countries.

Under-reporting stands as one of the biggest challenges of occupational medicine. One solution to this problem was identified in connecting ICD codes with the ILO list and criteria, and building a flagging system based on this connection, which would suggest to a physician that a disease might be occupational in its origin. Another important aspect on which all participants agreed was the necessity of collaboration between the general practitioners, different specialists, and occupational physicians.

As the most pursued of consequences, it is going to empower health and safety professionals and stakeholders, in particular in developing countries, to contribute to promoting harmonization of recognition, diagnosis, prevention, and compensation of occupational diseases.

Modernet Membership and fee

Modernet is an international membership association, in which members are individual persons - involved in work or dedicated to research into the objectives of Modernet.

Modernet has three classes of members: "Professional," "Emeritus," and "Student".

Professional Membership: any person involved in work dedicated to the objectives of Modernet. Each Professional Member shall pay annual dues as established in accordance with these statutes. Each Professional Member shall have one vote on all matters on which members are entitled to vote, and shall be eligible to hold office.

Emeritus Membership: any person who was formerly involved in work dedicated to the objectives of Modernet, who is currently retired and not employed on a full-time basis. Each Emeritus Member shall pay annual dues as established in accordance with these statutes. Each Emeritus Member shall have one vote on all matters on which members are entitled to vote, and shall be eligible to hold office.

Student Membership: any person enrolled in a higher education program who has an interest in promoting the purpose of the organization as set forth in these statutes. Each Student Member shall pay annual dues as established in accordance with these statutes. Each Student Member shall have one vote on all matters on which members are entitled to vote, and shall be eligible to hold office.

Any person who shall, upon application, show active employment, affiliation or matriculation and provide payment of dues, may become a member of the appropriate class.

Become a member for **25 euro** per year, running from 1-1 until 31-12
It has to be paid into the Modernet bank account
